

PRIVACY POLICY



Respecting and protecting your Personal Information (please refer to the definition of Personal Information at the end of this policy statement) is very important to us. It is also a Constitutional right, legal and a good business practice requirement that we take very seriously.

In line with the 8 Conditions in the Protection of Personal Information Act, 4 of 2013 (the Act) we

- 1. Accept joint responsibility and accountability with you to responsibly manage and protect your Personal Information when providing our services and solutions to you
- Undertake to receive, only from you, and process the Personal Information that is
 necessary to assist you with your required solutions, conclude the necessary related
 agreements and consider the legitimate legal interests of everyone concerned, as
 required by the Act and to respect your tight to withdraw your consent for the
 processing of your Personal Information
- 3. Undertake to only use your Personal Information for the purpose required to assist you or provide a solution
- 4. Undertake not to share or further process your Personal Information with anyone if not required
- 5. Undertake to be open and transparent and notify you as and when required by law regarding why and how your Personal Information needs to be collected
- 6. Undertake to safeguard and protect your Personal Information in our possession
- 7. Undertake to freely confirm what Personal Information we have, to update and correct the Personal Information and to keep it for no longer than legally required

We or the companies who provide or assist with solutions for you, need to collect, use and keep your Personal Information as prescribed by relevant laws and regulations and for reasons such as:

- 1. To share with and provide relevant products and services to you, to carry out the transaction you requested and to maintain our relationship
- 2. To respond to your queries
- 3. To confirm and verify your identity or to verify that you are an authorized user for security purposes
- 4. For insurance underwriting purposes
- 5. To assess and process claims
- 6. For operational purposes required to assist you with the solutions you require
- 7. For audit and record-keeping purposes
- 8. In connection with possible requirements by the Information Regulator or other Government agencies allowed by law, legal proceedings or court rulings.



We may need to share your Personal Information and/or utilize software or online platforms to enter and process your information for an application, claims or business management purposes. This will only be done in strict adherence to the requirements of the Act.

Your Personal Information is defined by the Protection of Personal Information Act as:

"means information relating to an identifiable, living, natural person, and where it is applicable an identifiable, existing juristic person, including but not limited to

- a. Information relating to the race, gender, sex, pregnancy, marital status, national, ethnic or social origin, colour, sexual orientation, age, physical or mental health, well-being, disability, religion, conscience, belief, culture, language and birth of the person
- b. Information relating to the education or the medical, financial, criminal or employment history of the person
- c. Any identifying number, symbol, email address, physical address, telephone number, location information, online identifier or other particular assignment to the person
- d. The biometric information of the person
- e. The personal opinions, views or preferences of the person
- f. Correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence
- g. The views or opinions of another individual about the person
- h. The name of the person if it appears with other personal information relating to the person or if the disclosure of the name itself would reveal information about the person."
